Update on Ridgeview Elementary School 2023-2024 School Opening and Transition Mrs. Robinson presented an overview of the first 10 days of school and updated the School Board on the transition of Ridgeview Elementary School. Clintwood Elementary will be transitioning to Ridgeview Elementary in August of 2024.

I. Stronger Connections Grant Application

Mrs. Robinson presented information about the Stronger Connections Grant Application. Dickenson County Public Schools qualifies as a high-needs LEA and is eligible for the Stronger Connections grant award. Usually, with a State Security Grant, you have to wait for the school to age five years before you are eligible to apply. This year we can apply now. Funding is between \$300,000 and \$350,000.There is no match on this grant. This grant will provide the safety framework for RES just like RMS and RHS. This will enhance our safety features in all schools, specifically at Ridgeview Elementary School.

I am very excited that you don't have to wait five years to be able to take advantage of this and make some improvements to the buildings.

Damon Rasnick - I appreciate the Superintendent keeping us informed about all the things that transpired. Things work better when you have four years olds up to eighteen and nineteen years olds in buildings and when you get ready to dismiss the intercoms not working. That makes it kind of hairy, to say the least. It takes of few days to get used to things. It is a stressful time for the parents, students, and employees. Everybody has to have their best game on. It's so important for children to have a day as stress-free as possible. Having been a principal, when sometimes buses miss some folks, you can imagine the parents on the other end when their kids don't get off the bus. It is something that we take very seriously. It sounds like everybody involved did an excellent job. I am very pleased with that and I hope it continues. Thank you.

Dr. Lurton Lyle - I am thankful that we had a reasonably good first ten days of school with the addition of Ervinton Elementary and Sandlick Elementary apparently going well. I am looking forward to Clintwood Elementary joining it. The construction appears to be going well also. Thank you.

Rick Mullins - I think it is really good to hear that we had several students moving in from out of state. I think that is a positive trend. Maybe those things that they said, that our population was going to continue to drop in the Coalfield may not be true. I was pleased to see the positive progress of the construction of the new school. It was really great to see the positive coming together of the opening of the school which I call the opening of Ridgeview and the consolidation the greatest undertaking ever accomplished in Dickenson County.
