The happiest time was opening Ridgeview High School. So you can see it's the same thing, my happy time and sad time was one. I have no regrets. Ridgeview led me to be voted off of the School Board. Ridgeview opening was one of the happiest times of my term on the school board. My support of consolidation led me to be voted off the board for four years. After it was opened I think everyone in the county became a Wolfpack fan. While talking about my part in this, Superintendent Haydee Robinson and School Board Attorney, Scott Mullins had a whole lot more to do with this happening than I did. I was supportive of it, but they did the groundwork or all of the work, from my point of view. It is hard to mention all the good times that happened during 30 years. Twenty-six years and six months on the board and four years voted off. It was well worth it, I have no regrets. I think we have a good replacement for my position. Thank you.

I weigh you down a bit and I get long-winded but you are all a good board and I am really looking forward to Dave coming on the board and appreciate you being here. Rick Mullins - It was great to see all the successes of all of the students, all the coaches, and everybody that was here tonight. You have the DECA class, you have the Ridgeview Band, the robotics, carpentry, Chris Owens and the hoop house, and the drama class. I think what I am going to do is call over to some of the School Board Members in Wise County and tell them we get these really nice things that the carpentry people make and see if they can outdo that in Wise. We have so much to be thankful for. I can't help but think a decade ago, none of us was sitting here and none of this was possible but all of this came as a dream and that's what life's all about. We had the people to acquire that dream for the people in the community. We are so blessed.

Dr. Lurton Lyle: I would like to add one more comment. I wore my Ridgeview hat and my Clintwood Jacket as emblems of the same thing, my happy time and my sad time.

Damon Rasnick - I would hope that all this good news finds a way to get out into the public. I could not help but think about, especially with those younger kids, we have three grandchildren and when they have ball season, you have one playing in one place in the county another playing in Wise County, and another playing in another place in the county. It takes a whole crew to go out. You know with all the traveling and all the food and all the getting back home late and getting lessons and all this. Growing up we didn't have that kind of opportunity. Most of us the coach had to take us wherever we went. Most parents including mine didn't have an automobile that was suitable to drive. It is amazing what it takes to run this school and all these activities and to see the rewards and the accomplishments of all these people. The students and the teachers and the families. Every person in this entire county has to be affected in some way. In a good way with all of this. It is just amazing to me that sometimes the word doesn't get out in the way that I think it ought to. These teachers put in all this time extra and I know that there's maybe some extra money but that's not it. These kids do this for honor excellence and pride. That's the kind of thing we need to certainly make it contagious and forever. I think what was here showed us so much. Even among the things that we have sometimes, we seem short-handed. It's never been with confidence or with compassion or with respect to each other basically. I think that most people that I've worked with in

We have come a long way, our kids have come a long way, our community has come a long way and our County has come a long way. I am proud of Dickenson County and I am proud of its people. I certainly want the best for our kids in every way possible. I also remember the sad times that we sometimes face and how many families we've gotten in distress out there. Mr. Mullins told me he had nine bodies at the funeral home. I looked at the Clintwood site and they have several. I look at Haysi and they have several. I think of all those families and I think of the time of year and it breaks my heart. I certainly want everything good that can come to these kids to come to them in a good humble respectful manner and a confident manner. I hope the teacher and all the employees probably study the words empathy, sympathy, and respect and realize that good health is not just having the absence of illness or infirmity but it means that you have a complete state of mental, physical, social, and economic and I would say philosophical or maybe spiritual base to help carry you through this difficult world we are in. I am sure in some way our teachers and everybody that sees these kids touch on that somewhere through their lives. I certainly think about those people out there. We've got to realize a lot of people are struggling now in different ways. Just to have those kids come and show the good, it sure boosted my spirits and I am so proud of them.
