Mr. Curtis Elswick, Sr. Vice President/Regional Executive with Skanska presented the Ridgeview Elementary School Classroom Addition PPEA.

j. Approval of the 2023 DCPS Construction Improvement Plan

Mrs. Robinson presented the 2023 DCPS Construction Improvement Plan.

A School Board approved DCPS Construction Improvement Plan is part of the process application for the School Construction Assistance Program.

The School Construction Assistance Program was created at the 2022 Special Session of the General Assembly to award grants on a competitive basis to local school boards that demonstrate poor building conditions, commitment, and need in order for such local school boards to be able to fund the construction, expansion or modernization of public school s buildings. A minimum of 65 points (on a 100-point scale) must be met for a project to qualify. The list of criteria includes:

- 1. Lack of building access modernization improvements as required under the Americans with Disabilities Act
- 2. Percentage of Students for Free or Reduced Price Meals
- 3. School Division's Composite Index

- 4. Percentage of Low-Income Families or percentage of families below the federal poverty guidelines
- 5. Locality Fiscal Stress
- 6. Debt Capacity of the Locality

DCPS scores above the 65 points required, and therefore qualifies to apply for this competitive construction grant.

VI. BOARD COMMENT

Jamie Hackney: I don't have much I just hate I missed the recognition of students that had won awards academically. Congratulations to all of those students. I would also like to extend appreciation to Tim and Curtis for their presentations and also to Ms. Taylor for the work on the budget. It seems like everything is moving forward as well.

Jason Hicks: It's always great to see the accomplishments of our students and their sponsors and coaches and teachers and all of those things. That's what it's all about so it's really good to see those things. I am really excited about the school. The pictures get you fired up. It's going to be a welcome sight to students once they get in there. I am sure it'll be a sweet day on day one when they do make it in there. I am excited about the possibility of another addition. Hopefully, we can make that happen and hopefully, Richmond will accept our grant and send it to us.

Damon Rasnick: I have reflected throughout between that last meeting and this meeting about things. It's still hard to believe that a hundred million dollars plus came to Dickenson County for the purpose of renovating because of the dangers imposed by flooding etc. I have been seeing it in operation now for a number of years. It's even more impressive to me than before. It looks impressive. It's beautiful. To see all the awards come up and all the winners we have and all of the competitions. Seeing our SOL scores move up from the lower quartile to the upper quartile and percentages. To have all these other competitions and activities that our children basically never got to do at Ervinton High School and later Clintwood and Haysi. This was too common and it certainly shut a lot of doors for a lot of students, technology remedied some of that. We had classrooms taught from Wise County and from the colleges etc. in our schools. Our kids had access to dual enrollment. I think that will expand here in this environment in a broad and very acceptable pattern. When you deal with Pre-K - twelve, with twelve you also deal with the college environment with the large classes and opportunities available to those students that are willing to do the work. We always have to remember I think to keep this in mind. I hear people complain about this that and the other. I am guilty of it myself so I guess it is okay to complain. We need to be thankful for what we have and what we are going to have if things fall into place. Every child in Dickenson County will have the opportunity to be served by the best, regarding education, the best that Dickenson County has to offer. There couldn't be a better platform for that here. The instructors that are here, the administration, all the staff, and all employees that have contributed to this. The parents and grandparents. We have got to remember the people of Dickenson County send us the best schools in the county, the best children in the county. They are the best children in the county because they are the only children in the county. We need to keep that in mind. They need the opportunity like everybody else around this country. I think a lot has been done. The original event goes back to the Corps money coming in and opening some doors for us making the pathway a little broader, a little wider, a little longer, and a little easier for those students. I certainly look at this facility and the people that work here and the students that attend here and the parents and grandparents who take care of them and the neighbors and

other family members that all have to do with bringing them up. I don't think it could happen in a better environment than where we are up here on this beautiful mountain.

Dr. Lurton Lyle: It is good to see our students get recognized for their accomplishments. Sometimes we tend to focus more on their problems or our problems rather than their accomplishments. It is also good to see the work coming along on the new edition. Hopefully, before too much longer we will have all of our students in one location. I believe that when I first got on the Board we had five elementary school buildings, three high school buildings, and a shop building, so that's about nine different buildings. I believe we are making some progress. I hope we continue.

Rick Mullins: I would like to thank Tim Burge and Curtis Elswick for coming and giving us the update on the elementary school. What a wonderful job you all have done. I would like to thank Ms. Taylor for all the hard work she has done on this budget. I know it's not been easy. Somebody else I would like to comment about is Shawn Tiller who stepped up in Phyllis Mullins's DEA position. Hat's off to you Shawn. I would like to thank and congratulate Joy Hall with the Beta Club she has done an absolutely wonderful job here. My old buddy Chris Robinson with the DECA has been so consistent and done such a wonderful job with those children. I think that's what this school system is all about. It's just wonderful and it's a blessing.
