j. Approval of FY24 Virginia State Budget

Laura Taylor, Director of Business and Finance presented the approved FY24 Virginia State Budget to the School Board:

Earlier in September, the Virginia General Assembly approved a budget that included an additional 2% raise in salaries from last year's salary in addition to funds to address learning loss, tutoring opportunities, and chronic absenteeism.

On September 14th, 2023, Governor Youngkin signed the Budget Bill approved by the General Assembly for Fiscal Year 2023-2024.

At this time, we have not received revised Calc Tools from VDOE. The estimates for additional funding to Dickenson County Public Schools at this time are

- \$1,111,629 Per Pupil Funding to be used to address Learning Loss and implementation of the Virginia Literacy Act
- \$ 312,981 Increase to State Share toward existing support staff salaries & benefits
- \$ 119,606 Additional 2% increase from 22-23 to SOQ-funded positions, effective 1/1/2024 (partial year)
- \$1,544,216 Total Expected Increase in State Funding FY 23-24

k. 2023 - 2024 Attendance Slogan and Chronic Absenteeism

Mrs. Robinson did a PowerPoint presentation to introduce the new Attendance Slogan #RUNWITHTHEPACK! BE HERE!



As we review our data for the 2022 – 2023 school year, 413 DCPS students, approximately ¼ of our students, missed 18 or more days of school. This is a significant number of students. SOL test results and assessments across the state and in Dickenson County indicate that students who missed 18+ days of the school year scored 18% lower than students with regular attendance in English assessments last year. Students who miss 36+ days scored 31% lower in reading assessments than students with regular attendance. In Math, the impact of attendance is greater. Students who missed 18+ days of school scored 25% lower than students with regular attendance in math, and students who missed 36+ days scored 43% lower than students with regular attendance in math.

Simply stated: The impact of attendance on learning and test results is evident, Children cannot learn if they are not in school, and they cannot be expected to do as well as their peers on assessments when attendance is an issue. Attendance is the area where all our families can have an immediate, positive, and significant impact by ensuring that their child is at school every day.

I. 21st Century Community Learning Center for RES and CES Award Announcement Mrs. Robinson - We are pleased to announce that Dickenson County Public Schools in collaboration with the Communities in Schools of Appalachian Highland has been awarded a three-year grant of \$199,994 to create a second 21st Century Community Learning Center after-school program for Ridgeview Elementary School and Clintwood Elementary School. This program for PK – to 5th grade, Jr. Wolfpack After the Bell, will be an incredible resource for Dickenson County families by supporting students through fun enrichment, and academic activities extending the educational experience into the after-school hours. Students currently attending CES will be transported to RES at the end of the school day.

VI. BOARD COMMENT

Rick Mullins - It was good to see all of the schools accredited with the pass rate on the SOLs. It was good to see some of the statistical scoring we did well on. It was good to see that the General Assembly approved the two percent raise for our school system which is badly needed. I was really glad to see the chronic absenteeism for us to take the initiative to apply ourselves to prevent and increase the students being at school, where they should be.

Dr. Lurton Lyle - I feel that our meeting tonight is a combination of celebration and concern. Celebration over the building process and the SOL results. Obviously the concern over chronic absenteeism. The proposed action is a positive factor also.

Jason Hicks - First of all it's very good that we can celebrate the budget edition from the state. That's very good news for our teachers and all of our staff. They certainly deserve it. The SOL scores, there is a lot to be proud of there. Hat's off to our teachers and staff and everyone that is a part of that. If we can tackle this chronic absenteeism some, I think those numbers will shine even a little bit brighter when we climb up there with those. It's very impressive with all the things that are going on in our school system with the new communities in schools that can support our students, the propel counseling that we have going on along with the after-school programs. When you think of all of the great services we have along with the great teachers and staff that we have I don't know why anybody wouldn't want to be at school. Being around a bunch of good people and with a lot of good things going on. So hopefully, our families will partner with us and make those numbers go down.

Jamie Hackney - I do think utilizing those as Jason said, the communities in schools, propel, and also the Department of Behavioral Health and some of the services they provide can help address some of the issues that we are talking about along with many others. I am glad to hear about the 21st Century Community Learning Grant. That is very good news to secure that. I am also always happy to hear about the budget process from the state. It was kind of long-awaited but the good news arrived now so that's great news for our staff and our teachers. I just kind of echo what some of the others said. The challenges and the good news with accreditation and the scores.

Damon Rasnick - The accreditation score was certainly to be commended. That takes an awful lot of people to do an awful lot of work to have those outcomes. It certainly is important for students to be here and teachers to be here as often as possible. If we don't have either there on an extended basis we have got a problem, a serious problem. I would hope that with all of the restrictions that we had before that are now gone, that everybody is informed of that. It's kind of hard to get that word out in terms that are reasonably understood after going through those two years in the way that we did. You know, the fact is that those scores probably show what happened for those years that we were. I certainly appreciate the work that has been done and the outcome that has been achieved. I hope that it keeps going up and up and up until we are back in the top quartile and lead the state. I think we are capable of that.
